Affiliation, Accreditation, Texas State Authorizations

The Islamic Seminary of America (TISA) holds *affiliate status with The Association of Theological Schools in the United States and Canada*, but is not an accredited member of the Association. Accreditation is a process that typically takes several years—no seminary or college is able to attain accreditation from its inception. The Islamic Seminary of America is not currently accredited, however, The Islamic Seminary of America Board of Trustees (the governing body of TISA) has made accreditation a top priority, and it has appointed a compliance committee with the primary task of overseeing the accreditation process. We will keep our students abreast of these developments, and, God-willing, we will be accredited soon.

Currently, The Islamic Seminary of America, a corporation that was established in the state of Connecticut, is registered with the Texas Secretary of State as a foreign corporation. As per the regulations of the Texas Higher Education Coordinating Board, TISA has received a “no approval needed letter” from the Board based on the fact that TISA is “a religious institution which would like to offer degree programs or courses leading to a degree in a religious discipline”.

History

The Islamic Seminary of America was founded in June 2016 and grew out of the vision by several Dallas-area based leaders to establish the first accredited Muslim seminary in America. On April 10, 2017, the Islamic Seminary Foundation entered into a MOU with the original Islamic Seminary of America board, transferring the name and all assets of the original Islamic Seminary of America to the board of directors of the Islamic Seminary Foundation which officially changed its name to The Islamic Seminary of America in November of 2022. The Islamic Seminary of America is a registered 501c3 organization under the US tax code.

Programs Offered

The Islamic Seminary of America offers two advanced degrees and one certificate. The two advanced degrees are the Master of Arts in Islamic Studies and the Master of Divinity degree.

- Graduates with a *Master of Arts in Islamic Studies* will be conversant with the major classical and modern texts in the main areas of Islamic scholarship, accessing the texts in their original language, with the ability to lead from an Islamic paradigm while engaging contemporary challenges and opportunities.
- The *Master of Divinity Degree* is designed primarily, but not exclusively, for persons seeking to be spiritual leaders in the Islamic faith and tradition. This degree is interdisciplinary in focus and intended for professionals who seek to enhance their knowledge of Islam relevant to their profession with the ability to lead from an Islamic paradigm while engaging contemporary challenges and opportunities.
- The *Islamic Leadership and Management (ILM) Certificate* is designed to enhance the leadership capability of those already serving in various leadership capacities within and outside the Muslim community. It is a 5-course graduate level certificate designed for those in Islamic centers, nonprofits and Islamic schools who want to enhance their leadership skills without taking a full master's level degree.

General Admission Requirements

Degree-seeking students must submit:

- A completed application
- Official transcripts from their college or university of their undergraduate and/or graduate academic work
- Three letters of recommendations
- A writing sample

Applicants with degrees from non-accredited schools may be accepted on a case-by-case basis. A background in Islamic studies and/or liberal arts is highly recommended and a plus for admissions. However, a background in Islamic studies and/or liberal arts is not required.

TISA reserves the right to request TOEFL or other English language assessment scores if the student's undergraduate degree was obtained in a language other than English.

Master of Arts in Islamic Studies

Careers

The Master's degree in Islamic Studies provides the background for a student to serve as a teacher in Islamic schools, public schools or junior colleges. The Master's degree in Islamic Studies is also a stepping-stone for those who wish to pursue a doctoral program in Islamic Studies.

Accredited Joint Master of Divinity in Interreligious Chaplaincy (Islamic Focus)

Note: This degree is granted by The United Theological Seminary of the Twin Cities

The joint Master's degree in Interreligious Chaplaincy with an Islamic Focus provides the background for a student to serve in interfaith settings as a Chaplain in corrections, the military, educational institutions, healthcare facilities, and the community. This joint degree program was implemented by The Islamic Seminary of America and The United Theological Seminary of the Twin Cities through a signed memorandum of understanding. The degree for this program is awarded by The United Theological Seminary Twin Cities, which is accredited by the Association of Theological Schools and the Higher Learning Commission.

- All Joint MDiv degree-seeking students are required to attain a passing grade for Fawakih Institute's Level 4 assessment for Arabic plus a TISA assessment before graduating from this program.

Arabic and Qur'anic Proficiency

The following two proficiencies must be demonstrated successfully as soon as possible and prior to the student's taking the last 9 credits of their degree. This means that if these two requirements are not met, the student will not be allowed to take their last 9 credits until they have met these requirements.

- All MAIS degree-seeking students are required to attain a passing grade for Fawakih Institute's Level 2 assessment for Arabic plus a TISA assessment before graduating from TISA.
- All MDiv degree-seeking students are required to attain a passing grade for Fawakih Institute's Level 4 assessment for Arabic plus a TISA assessment before graduating from TISA.
- All degree-seeking students are required to demonstrate the memorization of 1 Juz of Qur'an with Tajwīd before graduating from TISA.

Certificate Program

This five-course graduate certificate is designed to provide an academically rigorous and practically oriented program for those currently serving as leaders or considering leadership roles in Muslim Nonprofits, Islamic schools and Islamic Centers in North America. Financial Information

Enrollment and/or matriculation in The Islamic Seminary of America constitutes an agreement by the student to comply with all TISA rules, regulations, and policies.

Withdrawal

- Students who choose to withdraw from TISA must submit proper written notification to the Registrar’s Office.
- A leave of absence is a special category of withdrawal that may be requested by a student who intends to withdraw for a period not to exceed one year from the end of their last term of enrollment.
- Readmission after a period of absence exceeding one year requires reapplication through the admissions process.
- Readmission following a withdrawal or leave of absence longer than one year is subject to the approval of the Admissions Committee.
- Students readmitted following a withdrawal are subject to the program requirements of the academic year under which they re-enter.

Refund Policy

No refunds will be issued based on verbal discussions with any TISA representative. Waivers of this policy can only be made in writing by authorized TISA administrators.

1. Only Tuition is refundable. The Application Fee and Administrative Fees are non-refundable.
2. Tuition is refundable according to the following schedule:

Financial Aid

TISA has a policy to never turn down a regular student for financial reasons. Any student who feels that they need financial aid must complete the application for financial aid. The students will be informed of TISA's decision within 3 weeks. Only Regular Students are eligible for financial aid. Financial aid will be applied to student accounts only after the Add/Drop period ends.

Academic Regulations and Procedures

The Academic Year

The academic year is divided into Fall, Spring, and Summer terms.

Coursework

Regular attendance is expected in all classes. In the event of unavoidable absences, students are responsible for securing from their colleagues any information about lectures or assignments missed, and, if their absences are unexcused, they assume the risk of failing quizzes or other graded in-class work.

All course assignments are to be completed on time. Work submitted late may be accepted at the instructor's discretion and may incur a penalty in grade. Students are required to consult with the instructor in advance if circumstances make it impossible to meet an assignment deadline.

Course Recording Availability

Students that have had excused absences and would like to catch up with the class recordings, can do so up until the Grades Due deadline for the semester. Once that date has passed, the class recordings will no longer be available to students. It is students' responsibility to complete all of their makeup work by the end of the semester.

Academic Responsibility

Each student at TISA is expected to adhere to rigorous standards of academic honesty. Plagiarism and other acts of academic dishonesty are regarded as serious offenses and are treated accordingly. Students are advised to consult with their course instructors if they have any questions about expectations and procedures in this regard.

Accommodations for Students with Disabilities

The Islamic Seminary of America makes best efforts to facilitate individual accommodations for persons with disabilities who notify the Registrar in writing accordingly at registrar@islamicseminary.us. Faculty members are notified in writing when students in their classes have disabilities and need accommodations for class work and exams.

Student Grade Rubric and Access

Students can view their semester grades online using their assigned ID number and password.

- Grade points are determined on the basis of hours attempted according to the following grade symbols and scale:
- Grade Symbols:
 1. A - work of excellent quality
 2. B - work of commendable quality
 3. C - work of acceptable quality
 4. D - work of minimal but passing quality
 5. F - failure to do minimal passing work; with no credit given
 6. AUD - Audit
 7. I - Incomplete / Grade Deferred
 8. W - Withdrawal
 9. R - Retake
 10. TR - Transfer
- Students should not assume that credits will automatically or unequivocally transfer to or from any educational institution.
- Before executing an enrollment contract or agreement, all students are advised to confirm whether or not TISA will accept any credits earned at another educational institution.

- Should a student decide to transfer credits earned at TISA to another educational institution, it is advised to contact that institution to determine whether or not those credits will transfer.
- The ability to transfer credits earned at TISA to another institution may be limited and may necessitate repeating courses at another institution.

- B- is the minimum grade for course work credited towards a degree.
- If a student receives below a B- in a required course, the course must be repeated until a passing grade is received.
- When a student retakes a course, either to rectify a failure or to improve a grade, both grades will be included in the student's cumulative grade point average (GPA).
- If a student feels that their final semester grade in a given course is not fair, the student must discuss the grade with the course instructor.
- If the student is not satisfied, they may then appeal to the Academic Dean by filing a written statement of particulars via academics@islamicseminary.us and registrar@islamicseminary.us.
- The Dean will confer with the faculty involved and seek a satisfactory resolution of the problem.
- If the problem cannot be solved in this manner, the Dean may make a decision on the matter or, at their discretion, or may refer it to the Academic Council for final adjudication.
- All grade changes must be approved by the Academic Dean and must be made within one year after the course for which the grade in question was given.

Academic Standing

- Students whose semester GPA falls below 2.66:
 - For the first time will be placed on academic warning by the Academic Council.
 - The second or third time a student's semester GPA falls below 2.66 whether or not in consecutive semesters, the student will be placed on academic probation. If the semester GPA falls below 2.66 a fourth semester, the student will be dismissed for academic cause.
- Students who fail to receive at least a B- in a course in any term will be contacted in writing concerning their performance.
- Students who fail to receive at least a B- in the same course a second time will be automatically placed on academic warning.
- Students who fail to receive at least a B- for the same course a third time will be dismissed for academic cause.
- Students who fail to receive at least a B- in three or more courses at any time during their TISA studies will be placed on academic warning.
- Students who fail to receive at least a B- in five or more courses will be dismissed for academic cause.
- Academic dismissals occur when a student has either failed to meet the GPA requirement, failed the same course more than three times, or failed five or more courses while at TISA.
- A student who has been dismissed may qualify for readmission as a degree student only by completing two consecutive semesters (at least a total of twelve semester hours) as a non-degree student at another Seminary with prior permission from the Registrar's Office.
- Readmission after academic dismissal can be granted only one time.
- Academic probation or dismissal will be recorded on the student's official transcript.
- Appeal of academic probation or dismissal may be made in writing to the Academic Dean.
- Appeal of the Dean's decision may be made in writing to the Academic Council. Further appeal, if warranted, may be made in writing to the President of TISA.

General Policies

Confidentiality of Education Records

The Family Educational Rights and Privacy Act of 1974 is a federal law that grants students the right to inspect, obtain copies of, challenge, and to a degree, control the release of information contained in their education records.

In general, no personally identifiable information from a student's education record will be disclosed to any third party without written consent from the student. Several exceptions exist, including: 1.) Information defined by TISA as directory information may be released unless the student requests that it be withheld and 2.) Information authorized by the student may be released to those individuals designated by the student.

Student Identification Number

TISA assigns each student an identification number. The student should furnish the identification number on all forms when requested because it is the primary means TISA has to identify the student's academic records and transactions related to the records.

Students are required to provide a passport-style photograph of themselves for their Populi profile immediately after acceptance into the program. This photo is required for security purposes and shall not be shared outside of TISA or used for any marketing purposes. Student registration will be considered incomplete without their photograph. The default position is that the student cameras are turned on throughout the online class period. Waivers of these policies will be considered on a case by case basis. Waiver requests are made by emailing the Registrar at registrar@islamicseminary.us.

Name Change

A student who has a change in name must provide to the TISA Registrar's Office his or her Social Security card or the form issued by the Social Security Administration, or a valid passport. Enrollment or records services for the student under the name different from the last enrollment cannot be accomplished without one of the above documents. All grade reports, transcripts, certificates, and diplomas are issued only under a person's legal name as recorded by the TISA Registrar's Office.

Contact Information

Each student must provide the TISA Registrar's Office with a current email, home address, telephone number, and local mailing address, as well as the name, email, address, and telephone number of a designated emergency contact. Students enrolling at TISA authorize TISA to notify their emergency contacts in the event of a situation affecting their health,

safety, or physical or mental well-being, and to provide these contacts with information relating to their situation.

Students are required to keep current all their addresses and telephone numbers including emergency contact details through TISA's web-based self-service system. Changes of personal information should be reported via email to registrar@islamicseminary.us. Students may be prevented from enrolling if their information is insufficient or outdated.

TISA issues all degree-seeking students an email address. Students may have other email addresses, but the TISA-assigned email address is the official address for TISA electronic correspondence, including related communications with faculty members and academic units.

Official TISA correspondence may be sent to student's mailing addresses or TISA email addresses on file. It is the responsibility of students to keep all their addresses current and to regularly check communications sent to them since they are responsible for complying with requests, deadlines, and other requirements sent to any of their mailing addresses on file or to their TISA email. Once students complete, drop-out, or are dismissed from TISA, they will lose access to the TISA-issued email address.

Degree/Certificate Declaration

Regular students must declare the TISA degree/certificate they are pursuing by completing the Degree/Certificate Declaration Form. If the students change their degree or certificate, they must re-submit the form. This policy does not apply to students who only audit courses. Once the Degree/Certificate Declaration Form is completed, only then will the students receive the email issued from TISA.

Transcript Service

A transcript is an official document of the permanent academic record maintained by the TISA Registrar's Office. The permanent academic record includes all TISA courses attempted, all grades assigned, degree received, and a summary of transfer hours accepted. Official transcripts and certifications of student academic records are issued by the TISA Registrar's Office for all students.

There is no charge for two or fewer transcripts. If you order more than two you will be charged \$5 for each additional copy above the two. No partial transcripts will be issued. Transcripts will not be released to anyone except the student, unless appropriately requested in writing by the student. TISA policy prohibits issuing transcripts to any student indebted to TISA. If you are ordering more than two transcripts, they are \$5.00 for each additional transcript.

Enrollment Policies

Stop Enrollment/Administrative Withdrawal

Insufficient or improper information given by the student on any admission or enrollment form—or academic deficiencies, disciplinary actions, and financial obligations to TISA—can constitute cause for the student to be determined ineligible to enroll or to be administratively disenrolled.

Graduation Policies

Apply to Graduate

Students must file an Application for Candidacy to Graduate form with the Registrar's office at the beginning of the term in which they will complete all degree requirements. Applications should be filed by the deadline date in the Official TISA Calendar. Students will be charged an Apply to Graduate fee during the term the application is filed. TISA has one degree conferral period: the Spring term of each year.

Commencement Participation

To participate in a ceremony, a student must file an Application for Candidacy to Graduate or Intent to Participate Form with the Registrar's Office.
